These countries comprising the new constellation of growth will continue to benefit from the demographics dividend, rapid urbanization, a growing middle class developing new consumption patterns and from the positive impact of fast growing intra-regional trade to sustain their growth. The Growth Net has been designed to boost the interaction among this group of countries, discuss their common challenges and address the issues raised by this new world order.
